PERFORMANCE OPPORTUNITIES:

RECITAL TICKETS:

TICKETS WILL BE SOLD ONLINE DURING THE MONTH OF MAY. THEY WILL BE \$ 15 EACH + HANDLING FEE. DANCERS WILL NEED A TICKET. (CHILDREN UNDER 2 YRS DO NOT NEED A TICKET BUT MUST SIT IN A LAP.) REMINDER: FOR STUDENTS IN BOTH SHOWS YOU WILL NEED TO PURCHASE TICKETS FOR EACH SHOW.

TUITION POLICY:

- THERE IS A REGISTRATION FEE OF \$ 25 PER FAMILY EACH YEAR.
- TUITION IS DUE, THE 1ST CLASS OF EACH MONTH. A \$ 5 LATE FEE WILL BE ADDED FOR EACH WEEK LATE AFTER THE 2ND CLASS. NO EXCEPTIONS.
- TUITION REMAINS THE SAME WHETHER IT IS A LONG (5 WEEK) OR A SHORT (3 WEEK) MONTH. (**FALL CLASSES BEGIN ON TUES. SEPT. 3rd**)
- TUITION IS NOT PRORATED FOR MISSED CLASSES.
- THERE IS A \$25 RETURNED CHECK FEE. MUST BE REPLACED WITH CASH. NO OTHER CHECKS WILL BE ACCEPTED. MAKE CHECKS PAYABLE TO "DANCE WITH STACEY"
- YOUR CANCELLED CHECK IS YOUR RECEIPT.
